On the other hand resourceful GIPSA -NIACL officials invoke a citizen's Right to Information as corporate incarnate;. e.g. one S. S. Hira, salary No. 15287 sought information from Central Board of Direct Taxes on 13.10.2009 regarding income IT/TDS challan, trading account, Audit report etc in respect of 4 persons. On behalf of NIACL second appeal was preferred against the Central Govt. It was heard on 3.01. 2011 by Central Information Commission (Appeal No. CIC/LS/A/2010/001130DS). The Chief Manager who secured iii rd party disclosure in the course of his official duty is promoted as Dy. General Manager, NIACL.
