Whereupon the undersigned, humbly pray and call upon the county assembly to promote, facilitate and prioritize public participation of all the key decisions undertaken by the county government and also investigate and probe about the gross misappropriation of funds and rampant corruption at the county government of Garissa.

Public participation is vital and the views of the people is used as the basis over which issues of priority is identified and addressed.

Therefore, this petition seeks to guide and advance and facilitate and agitate for public participation in governance processes and in particular to- give effect to the principles of public participation as provided in the constitution of the Republic of Kenya.
