CERTIFICATE OF URGENCY

I ERICK OMARIBA of Post Office Box Number 2012 - 00100, Nairobi in the Republic of Kenya, an Advocate of the High Court of Kenya do hereby certify this matter as urgent for the following reasons.

- 1. The Senate of the Republic of Kenya has issued Notice to appear before the Sessional Committee of County Public Accounts and Investment (hereinafter also referred to as (CPA&I Committee) for consideration of Reports of the Auditor General on Financial Statements for the financial year 2018/2019 hereinafter referred to as Audit Reports to the Chief Executives of the entities listed in the notice being County Executives in purported oversighting of the County Government entities to which it has no Constitutional or statutory mandate. Hence the said act is *ultra-vires* their mandate.
- 2. The process is a fallacy that will be funded by the taxpayers and as such any expenditure by the Senate committee traveling to the counties or the County entities travelling to Nairobi, directly costs the taxpayers in terms of expenses running the sessions
- 3. The intended hearings are therefore irregular have no legal backing hence void ab initial
- 4. The 2^{nd-} 48th Respondent have failed to perform their Constitutional and Statutory duty of diligently planning, guiding and leading debates and considering the Auditor General's reports on financial statements and making recommendations and should not continue to hold office.
- 5. The 49th-95th Respondents have failed to discharge their Constitutional and Statutory mandates by interrogating, considering and giving recommendations on the Auditor General's Reports on financial statement as required by the Constitution.
- 6. 1st Respondent has usurped the mandate of the 49th -95th Respondents causing serious breach of the Constitution and wastage of public resources.
- 7. The Constitution has stipulated clear timelines for the performance of the review of the Auditor General's reports to the various entities at both National and County level which timelines have not been respected.
- 8. If this application is not heard and directions given urgently the 1st Respondent through its County Public Accounts and Investment Committee will cause the members of the 1st interested parties to incur expense in attendance costs and

preparation of documents and responses to illegal summons at the expense of development.

9. The Respondents will suffer no harm or loss should the orders sought be granted pending the hearing and determination of this application.
