

**Vacancies on 28.  
the Committee:**

Subject to Article 27 the Committee shall have power to appoint a member to fill any vacancy on the committee until the next Annual General Meeting. Any member so appointed shall retire at the next Annual General Meeting but will be eligible for re-election as a member of the Committee at such meeting.

**Failure to 29(a)  
take up  
Position:**

Where two or more Committee members fail to take up their positions or where for any reasons two or more vacancies occur in the Committee the Management Committee shall call a Special General Meeting for election of members to fill the respective vacancies.

(b) If the unexpired term of the Management Committee is less than six (6) months, the provisions of Article 26 shall apply.

**Financial 30(a)  
Powers of the  
Committee:**

The Committee shall have power to incur such expenditure as is considered necessary and expedient in the running of the affairs of the Club.

(b) Capital expenditure on any single project in excess of Kshs.500,000/- shall be approved by a Special General Meeting.

(c) The Management Committee shall prepare a project proposal for presentation for the approval by the members at the special General Meeting. The said proposal shall be professionally drawn and evaluated

(d) Where the general meeting approves expenditure in excess of Kshs.500,000/- the Management Committee shall establish a three member Development sub-committee to be chaired by the Vice - Chairman for purposes of procurement and over-seeing the project PROVIDED that where there are more than one project in progress any other member or members of the Management Committee may chair the other Development Sub-Committee.

(e) Expenditure in excess of Kshs.500,000/- without approval or improper expenditure of any club funds may, on a resolution of the members lead to a surcharge against the Management Committee members for recovery thereof.

**Donations:** 31(a) The Management Committee may accept and receive donations, in cash or kind or in any other form, from donors, friends, members, well wishers or any other person or organization. Such

- 32(a) Where three or more Board members fail to take up their positions or where for any reasons three or more vacancies occur in the Management Board the Board shall call a Special General Meeting for election of members to fill the respective vacancies.
- (b) If the unexpired term of the Management Board is less than six (6) months, the provisions of Article 32 shall apply.

Powers of the

- 33(a) The Board shall have power to incur such expenditure as is considered necessary and expedient in the running of the affairs of the Club.
- (b) Capital expenditure on any single project in excess of Kshs.20,000,000/- shall be approved by a Special General Meeting.
- (c) The Management Board shall prepare a project proposal for presentation for the approval by the members at the special General Meeting. The said proposal shall be professionally drawn and evaluated
- (d) Where the general meeting approves expenditure in excess of Kshs.20,000,000/- the Management Board shall establish a three member Development sub-Committee to be chaired by any member of the Management Board for purposes of procurement and over-



seeing the project **PROVIDED** that where there are more than one project in progress any member or members of the Management Board may chair the other Development Sub-Committee.

- (e) Expenditure in excess of **Kshs.20,000,000/-** without approval or improper expenditure of any club funds may, on a resolution of the members lead to a surcharge against the Management Board members for recovery thereof.

- Donations:** 34(a) The Management Board may accept and receive donations, in cash or kind or in any other form, from donors, friends, members, well wishers or any other person or organization. Such donations shall be utilized or applied for the benefit of the Club.
- (b) The Management Board shall make full disclosure to the members on the source of such donations and the usage and application thereof.

- Quorum at Meetings:** 35. At the meeting of the Board, six shall be taken as the quorum of all proceedings of the Board by the Honorary Secretary.

- Meetings of Committee:** 36. The Board shall meet at least once a month and in addition a meeting shall be held one week prior to the commencement of each school term.
