1. I am female adult of sound mind.
2. I run a construction company called SIPHO SOLUTIONS LIMITED.
3. In the year 2024, I bid for a project at The Nairobi Hospital titled PROPOSED RADIOLOGY EXTENSION AT THE OLD PHARMACY. I had seen the advertisement for the tender in the Daily Nation in May 2024. I submitted my bid on 13<sup>th</sup> June, 2024.
4. As soon as I submitted the tender bid Prof. Herman Manyora, a director of The Nairobi Hospital started calling me incessantly and threatening me that he shall ensure my tender bid failed unless I gave him Kenya Shillings Two Million (KShs. 2,000,000). These threats became so intense that I had to send him money as follows:


5. He is the one who provided me with the bank account number via WhatsApp message from his telephone number 0722795380 to my telephone number 0727753442.



6. I was notified through an award letter that my company's bid was successful and awarded the contract. I believe that the award to my company was on merit.
7. From the period January 2025 to May 2025 Prof. Herman Manyora kept on soliciting for money from me coupled with threats of termination of my company's contract with the Hospital.
8. I wish to tender this affidavit in support of my ethical and integrity complaint against Prof. Herman Manyora. He has used his position as a member of the board for unjust enrichment. He is not fit to retain his position as a member of the Board.
9. Should the Hospital from whom he acts as a director not take appropriate and satisfactory measures I may be forced to involve government authorities.
10. What is deponed to hereinabove is true to the best of my knowledge, belief and information
